Given First Reading on the 14<sup>th</sup> day of May, 2024, and approved by at least a majority of the fiscal court members.

This ordinance will be read again, considered again, and possibly adopted by the Meade County Fiscal Court, 516 Hillcrest Drive, Brandenburg, Kentucky, on the 11<sup>th</sup> day of June 2024.

**AN ORDINANCE ADOPTING AND INCORPORATING 2024 KENTUCKY HOUSE BILL 575 INTO THE MEADE COUNTY ZONING ORDINANCE**

**SPONSORED BY: MEADE COUNTY FISCAL COURT MEMBER**

**WHEREAS**, the Kentucky General Assembly has passed or is in the process of passing 2024 Kentucky House Bill 575, incorporated by reference herein in full; and

**WHEREAS**, 2024 Kentucky House Bill 575 generally relates to prohibiting any nonresident alien, foreign business, foreign agent, trustee, or fiduciary who has a legal relationship with or is legally bound to take instruction from or execute decisions for the government of any proscribed country referenced in 22 C.F.R. sec. 126.1, as amended, from purchasing, leasing, or acquiring any interest in public or private agricultural land located in Kentucky, as well as participation in programs administered by the Department of Agriculture, Agricultural Development Board, and Kentucky Agricultural Finance Corporation; and

**WHEREAS**, the Meade County Fiscal Court intends to adopt and incorporate all these provisions of, and related provisions of, 2024 Kentucky House Bill 575 into the Meade County Zoning Ordinance.

**NOW, THEREFORE, BE IT ORDAINED BY THE MEADE COUNTY FISCAL COURT AS FOLLOWS:**

**SECTION I:** All the provisions of, and related provisions of, 2024 Kentucky House Bill 575 are hereby incorporated into the Meade County Zoning Ordinance; and

**SECTION II:** The Meade County Planning and Zoning Department, Meade County Planning Commission, Meade County Fiscal Court, or any other related

department of Meade County Local Government, shall make notice of any violation of the terms of the 2024 Kentucky House Bill 575 and report such notices to the Department of Agriculture or other applicable state agencies; and

**SECTION III:** The Meade County Planning and Zoning Department, Meade County Planning Commission, Meade County Fiscal Court, or any other related department of Meade County Local Government, shall facilitate the resulting directives that come from these aforementioned state agencies; and

**SECTION IV:** This Ordinance shall take effect upon its immediate passage and approval.
